Violation #2. Playground Equipment
Reaper torn floor in the playground

CODE REFERENCE: Playground Equipment 64E-13.004(2)(a)(c). Playgrounds shall be constructed and maintained to permit maximum utilization of sites with elimination of sanitary and health hazards including mudholes, fragments of glass, stone and similar obstructions. Fixed playground equipment shall be anchored with substantial foundations so maximum safety is obtained. Cushioning materials such as mats, wood chips, or sand shall be used under climbing equipment, slides, and swings.

Violation #5. Maintenance & Repair

Repair one non-working water fountain in the hallway next to calssrooms 322-331

CODE REFERENCE: Maintenance & Repair 64E-13.004(3)(b)(c). Buildings shall be kept clean and in good repair, free from hazardous conditions, such as loose or broken floor tiles and boards; loose moldings; loose hanging fixtures, pipes, and electric wires; and broken plaster. Furnishings and equipment shall be kept clean and in good repair, free of missing parts and hazards such as sharp edges, splinters, and protruding or rusty nails.
